



**YOUNG SHOOTERS (PATRONS UNDER 21)  
PARTICIPATION AGREEMENT AND WAIVER AND RELEASE OF LIABILITY**

**PLEASE READ CAREFULLY BEFORE SIGNING. THIS IS A RELEASE OF LIABILITY AND WAIVER OF CERTAIN LEGAL RIGHTS AND ASSUMPTION OF THE RISKS AGREEMENT.**

This Participation Agreement and Waiver and Release of Liability is entered into between the undersigned “**Parent**” or “**Guardian**”, the Patron under the age of 21 “**Participant**” and Ultimate Defense Firing Range and Training Center, it’s partners, sponsors, vendors, directors, officers, employees, volunteers, members, facilities and the owners and lessors thereof, hereinafter referred to as “**Ultimate Defense**”.

In consideration for the privilege of participation by the Participant in activities utilizing the Ultimate Defense facility, Participant, Parent or Guardian acknowledge and agree as follows:

1. Activities at the Ultimate Defense facility can be considered **HAZARDOUS AND PRESENT A POTENTIAL DANGER TO PARTICIPANT**. Participant and Parent or Guardian believe the Participant is qualified to participate in activities, and if at any time the Participant, Parent or Guardian believe conditions to be unsafe, he/she will immediately discontinue further participation in the activities.
2. Participant and Parent/Guardian have read and signed the Ultimate Defense Firing Range Rules and have attended the Ultimate Defense Young Shooters Firearms Safety Training Class.
3. Participation in activities at the Ultimate Defense facilities are also subject to all provisions of the Ultimate Defense general “Waiver of Liability” document to which this participation agreement is attached.
4. Participation in activities at the Ultimate Defense facility may expose Participant to **RISKS OF SERIOUS BODILY INJURY, INCLUDING PERMANENT DISABILITY, PARALYSIS AND DEATH**. I consent to participation in the activities under the provisions stated above and fully accept and assume all such risks and all responsibility for losses, costs, and damages incurred as a result of such participation.

**THE UNDERSIGNED PARTICIPANT AND PARENT OR GUARDIAN HEREBY CERTIFY THAT PARTICIPANT IS AT LEAST 13 YEARS OLD, THAT THE PARTICIPANT AND PARENT/GUARDIAN HAVE COMPLETELY READ AND UNDERSTAND THIS AGREEMENT AND ITS TERMS. PRIOR TO SIGNING THIS AGREEMENT, PARTICIPANT HAS HAD THE OPPORTUNITY TO ASK ANY QUESTIONS ABOUT THIS AGREEMENT. PARTICIPANT AND PARENT/GUARDIAN IS AWARE, THAT BY SIGNING THIS AGREEMENT, THEY ASSUME ALL RISKS AND WAIVE AND RELEASE CERTAIN RIGHTS THAT THEY MAY HAVE AGAINST ULTIMATE DEFENSE.**
